1. Job Description: Professional work prescribed in Article 3 of the

Qualifications and Criteria Standards of the Employment of

Foreign Professionals to Engage Professional Knowledge or Skills

at Short-term Supplementary Learning Centers (the Reviewing

Criteria of Category H) shall mean the following:

Technical creation or technical teaching in the digital content industry:

 Digital gaming industry (Code 01): home gaming software, computer gaming software or smart-device gaming software.

(2) Computer graphics and animation industry (Code 02).

(3) Sensory technology industry (Code 03): the following software/hardware development technologies:

- A. Virtual reality (VR)
- B. Augmented reality (AR)
- C. Mixed reality (MR)
- D. Interactive control applications
- E. Optical sensor applications

(4) Others (Code 99): teaching in other digital content industries with substantial contributions to domestic talent education approved by the central competent authority in consultation with the Ministry of Education.
